## **\*\*Invoice and Agreement for Temporary Body Art Services\*\***

To whom it may concern:

Thank you for booking *Family Faux Body Tattoo* for your event. A signed agreement and half (1/2) of party booking deposit is required to secure the booking date agreed upon between client and artist. Verbal booking dates will be held for five (5) business days. Signed agreements emailed/faxed to *Family Faux Body Tattoo* will hold the booking date for seven (7) days to provide a wait period to receive your deposit. If the deposit is not received within seven (7) days of receipt of a signed agreement, the agreement is null and void. Please note that until deposit is received, your date will be considered “**unconfirmed**” and open to alternate bookings. The deposit is non refundable should the client decide to cancel the event one (1) week prior to the event date. In the case of postponement, *Family Faux Body Tattoo* will work with you to accommodate an alternate date one time. However, if a mutually agreeable date is not determined the deposit is retained by *Family Faux Body Tattoo*. Balance is due upon date of service. Please send a check made out to **Linda L. Krause** in the amount of half of party booking deposit to address **8102 Revere St, Philadelphia, PA 19152**. You may also send your deposit by PayPal however there is a \$FEE CONVENIENCES CHARGE FOR WANTING TO PAY WITH A CREDIT CARD. If you would like to pay by the way of PayPal please let *Family Faux Body Tattoo* know and we will send you a PayPal invoice.

*Additional travel charges may apply. All fees are subject to mileage charges for more than 30 miles/30 minutes travel outside of Philadelphia PA 19152. Everything within a 30 miles/30 minutes radius of Philadelphia PA 19152 will be **FREE!** In cases where distance traveled is longer than 30 miles/30 minutes there will be a \$.65 per mile charge as well as any toll or parking fees.*

**Limitations on Artwork:** Artist will not supervise children. Their behavior and safety is the Parents' responsibility. Artist cannot oversee the line of children waiting to be Mehndi/Henna and be in charge of who is next in line while he/she is tattooing, also for sanitary reasons, artists will not tattoo anyone who appears to be sick, suffering from any infectious skin condition or open wounds.

**Artist agrees** to provide services of general temporary body art Mehndi/Henna using only all natural Henna Paste containing only the powder of crushed henna leaves, Lavender, Geranium, and Cajuput Essential Oils.

**Client agrees** to pay the full amount of booked time upon artist's arrival at event. The artist will have no problem working outdoors under proper weather conditions, but a suitable shelter is required in every circumstance. Please provide sheltered area in event of rain. To provide shaded area in extreme heat. If not able to supply shelter please let artist know in advance so that he/she may pack accordingly.
